This well is located on BLM managed lands and is authorized under lease COC-066370. The proposed well will be drilled to a TD 7638 feet Measured Depth (MD) and a True Vertical Depth of 7632 feet (TVD). This Permit was originally approved July 24, 2013 (BLM) and July 20, 2014 (COGCC) for the previous Operator-Dejour Energy (USA) Corp. However, due to a change of operator, personnel and Best Management generally accepted drilling practices and procedures, a revised drilling plan is now being submitted to accurately reflect the well construction details.
