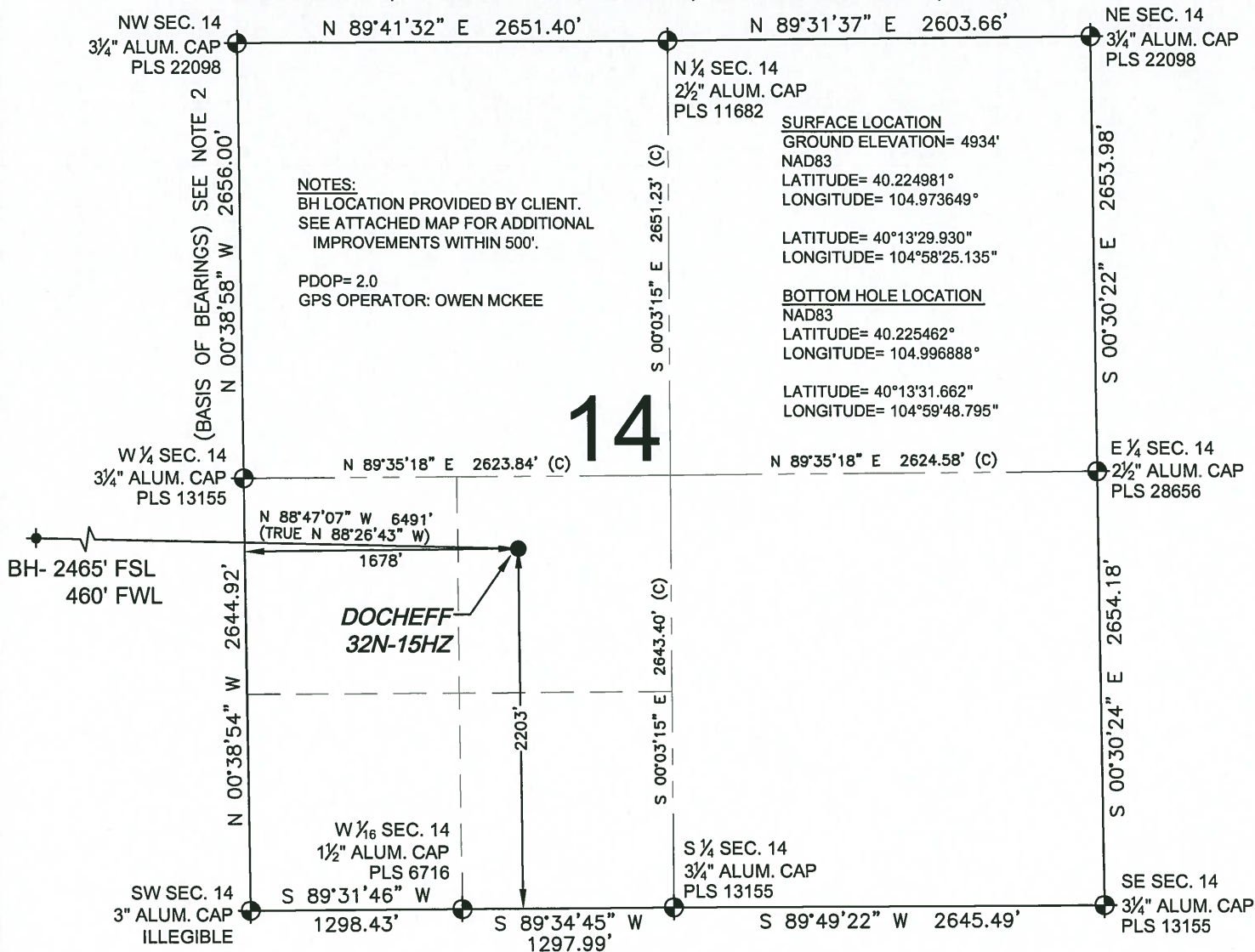


WELL LOCATION CERTIFICATE: DOCHEFF 32N-15HZ

- ◆ = EXISTING WELL

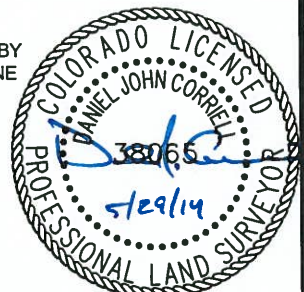
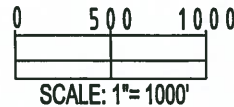
