We did further analysis of the aquifers in the area of PDC Energy's Tarin well pad located in Section 32, T4N, R66W. Our original offset well analysis referenced a water well in the area with a depth of 520 feet and the conditions of approval from the Colorado Oil and Gas Conservation Commission were based on the depth of this water well.

Additional research shows the base of the Fox Hills in the area of the Tarin well pad to be at +/- 222 feet. A well log from the area (the Glen #1, API 05-123-13678) does not show any sands below its surface casing depth of at 205'.

Based on this more detailed information, we would request that the conditions of approval for the following existing well near the PDCE Tarin well pad be changed from Option 1 or 2 to Option 4.  
(MONITOR BRADENHEAD DURING OFFSET FRACING. PULL TUBING, INSTALL RBP, PRESSURE TEST CASING TO 2000 PSI, INSTALL 5K WELLHEAD)
