This well was converted to observation by removing the production equipment from the well and isolating the zone of interest by setting a packer at 1540' and confirming the integrity through an MIT that was submitted to the COGCC on 10/14/2014. The well was perforated in the Raton/Vermejo formation on 1/5/2011. The zone was broke down with water to establish connection to reservoir.
