Approval for changing to option 4 granted contingent upon completion of successful Bradenhead test and submission of form 17 that shows no significant Bradenhead pressure or flow issues and that the well is in compliance with the COGCC "Policy for Special Bradenhead Testing Area in Weld County" dated 12/16/2009. If the results of the Bradenhead test are not acceptable additional mitigation will be required.

Option 4 remediation will include pulling tubing, installing at least 1 RBP, pressure test of casing, installing a 5K wellhead, and onsite monitoring of the Bradenhead during hydraulic stimulation of offset wells within a 1500' radius of this well.
