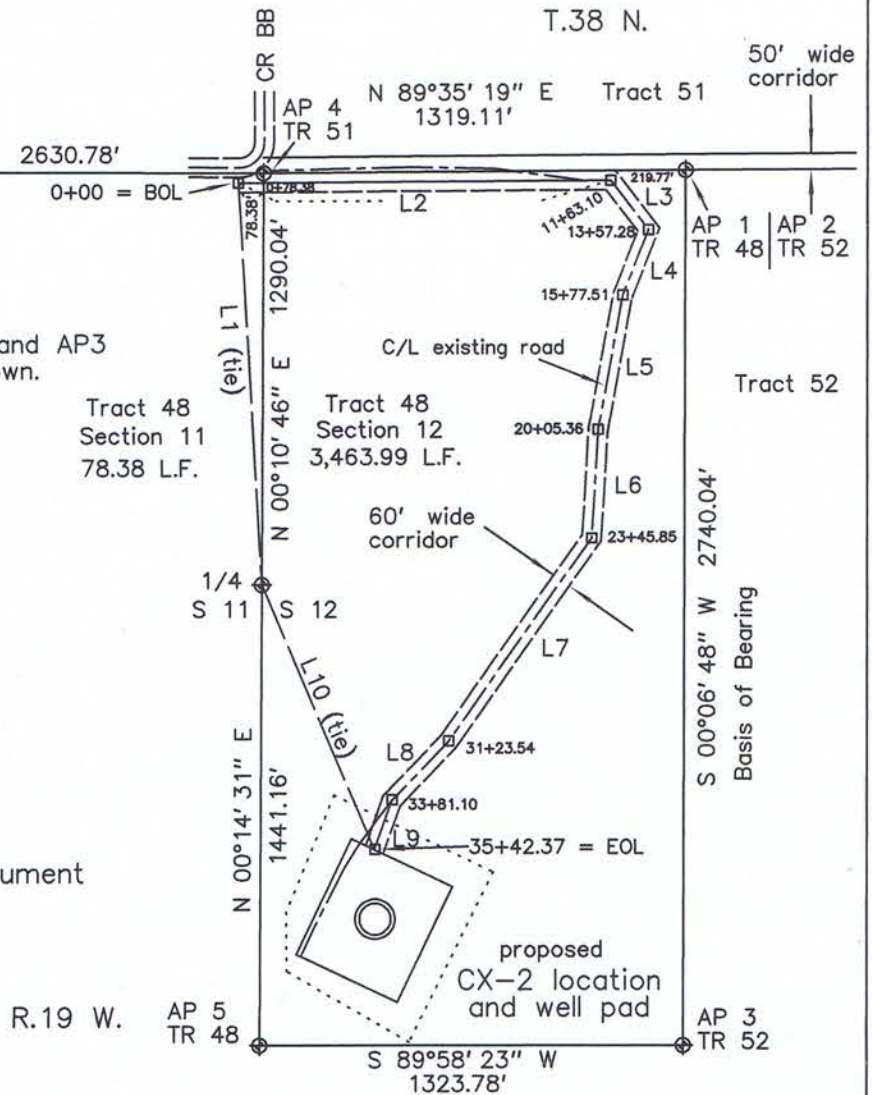

LEGAL DESCRIPTION – 60 Foot Wide Corridor

A 60 foot wide corridor contained in Tract 48 of Sections 11 and 12, T.38 N., R.19 W., NMPM, Montezuma County, Colorado, lying 30 feet each side of the following centerline description: Beginning at a point from which the E 1/4 Corner of said Section 11 bears S 03°22' 56" E a distance of 1261.67 feet; thence N 89°35' 19" E a distance of 1163.10 feet to the centerline of an existing road; thence S 37°29' 58" E a distance of 194.18 feet along said road centerline; thence S 21°19' 05" W a distance of 220.23 feet along said road centerline; thence S 10°13' 37" W a distance of 427.85 feet along said road centerline; thence S 03°25' 16" W a distance of 340.49 feet along said road centerline; thence S 35°04' 56" W a distance of 777.69 feet along said road centerline; thence S 43°17' 35" W a distance of 257.56 feet along said road centerline; thence leaving said road centerline S 19°35' 04" W a distance of 161.27 feet to a point on the proposed CX-2 well pad and the end of said 60 foot wide corridor, from which point the W 1/4 Corner of said Section 12 bears N 23°04' 39" W a distance of 900.17 feet. SUBJECT TO all easements of record or prescriptive.
