#### COMMENTS:

WPXENERGY request permission to set the surface casing shallow on the RWF 432-23 well (RWF 43-23 pad) Sec. 23, T6S, R94W. The original planned and approved permitted depth for this well was 1,129'. WPX made an additional wiper trip before running open hole surface logs and then began running our surface 9 5/8" surface casing. We hit a solid spot and are only able to get the surface casing to a depth of 1,089', which would leave the surface casing set approximately 40' short of our permitted depth. We have made a few attempts to pick up and wash the casing past this spot without success, we are able to circulate with good returns to the surface.

Dave Andrews gave WPX verbal approval on Friday, October 17, 2014 and request this sundry be submitted.
