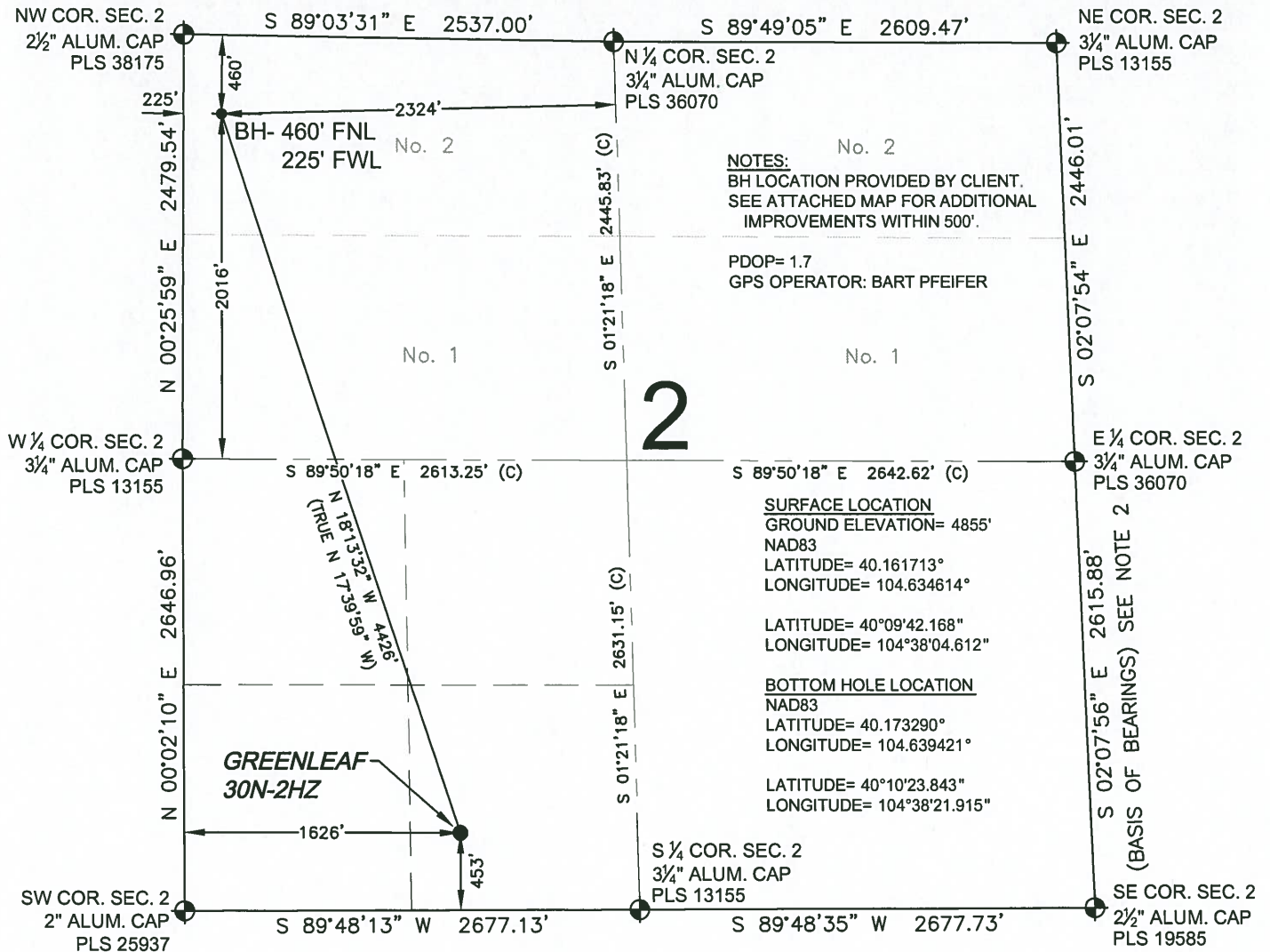


WELL LOCATION CERTIFICATE: GREENLEAF 30N-2HZ
