COMMENTS:

1 ND BOP's, ND wellhead, Un-land 4-1/2" casing, NU dual entry flange, NU BOP.
2 PU 1-1/4" 2.3#/ft J-55 10rd IJ tubing, and TIH outside 4-1/2" casing in open hole to ~5500'. Circulate with the rig pump while TIH to clean up the annulus. Use sweeps as necessary until clean returns are seen. Make sure no pressure is present on the bradenhead before moving on to the next step. If gas is detected, contact engineering to discuss a plan for moving forward.
3 Contact Imperial mud (min of 24hrs. in advance) to bring out 40bbls of 10.0ppg mud. Pump 40bbls of mud at 5500'. Leave 1-1/4" tbg full of mud to avoid a wet trip and PUH to 5120' to displace cement.
4 MIRU cement services (Baker). Pump 5bbls water, 10bbls mud flush, 5bbls water, 20bbls SMS, and 5bbls of water.
5 Mix and pump 315sx (~70.7bbls) of 14.2 ppg (1.26 cuft/sk) Class G cement and 1/4 lb/sk Cello Flake. The cement is to be retarded for 120 °F and 6 hour pump time.
6 TOO H 45 joints to ~3700' and circulate 2 times the tubing volume of water or until clean returns are seen.
7 PUH to 1200'. Mix and pump 175sx (~41.5bbls) of 14.8 ppg (1.33 cuft/sk) Type III and 1/4 lb/sk Cello Flake. The cement is to be retarded for 80 °F and 3 hour pump time.
8 TOO H 29 joints to ~300' and circulate 2 times the tubing volume of water or until clean returns are seen. TOO H with 1-1/4" tubing.
9 RDMO cementing company.
10 ND BOP. ND dual entry flange and crossover. Pick up and land 4-1/2" casing in slips. NU 4-1/2" 5000 psi tubing head with 2-5000 psi valves (use new style flanged well head equipment). NU BOP's to tubing head. Make sure all valves and nipples are rated to 5000 psi.
11 Leave well shut in for ~24hrs.
12 MIRU wireline and run CCL-GR-CBL-VDL from 7100' to surface. Verify new cement coverage with Evans Engineering. Design is for coverage from ~5120' to 4266' and ~1200' to 648'. In addition to normal handling of logs/job summaries, email copies of all cement job logs/job summaries and invoices to rscDJVendors@anadarko.com within 24 hours of the completion of the job.
