The original APD called for 1st string (9-5/8" casing) to be set at 3,000' MD/TVD. Due to mechanical problems with the drilling rig encountered at a drilled depth of 2,718' MD/TVD, Bonanza requested permission to set the 1st string at 2,710'. Verbal permission to set 1st string at 2,710 was granted by Dave Andrews (COGCC) to Randy Edelen (BCEI); on Friday 10/17/14.

Actual setting depth was 2,690'. 74.7 bbl of 12.5 ppg lead / 148.5 bbl of 14.6 ppg tail.
