Jaimie,

Attached is the sample location diagram from last year. You should try to get four samples from the same general vicinity as last year. If you are taking grab samples they should be collected from material that is most likely to remain impacted based on staining or odor. You should dig into the treatment pile to get material that hasn't been exposed to the sun on the surface.

Please note that the Remediation Project #6744 was approved on Nov. 30, 2011. Land treatment can be done on location for up to three years. After three years, the operator would need to have an approved Form 28 in place for a centralized waste management facility, or if the sample results indicate contaminants still exceed Table 910-1 standards, Saga should haul off the material for appropriate disposal and remit a closure request with all disposal documentation in accordance with Rule 907.b.(2) no later than Nov 30, 2011.
