Attached are the laboratory reports and the sample location map for the soil samples collected from the excavated area and landfarm in order to close the historical condensate release that occurred at the PA 43-34 well pad and was discovered on March 3, 2014. Grab samples were collected from the excavated area and composite samples were collected from the excavated material landfarms. All samples were analyzed for the abbreviated list of analytes that was approved by COGCC via email on March 5, 2014. The samples were analyzed for the organic compounds only (TPH, BTEX, and PAHs). The analytical data is summarized in the attached table.

As the attached lab reports indicate, all constituents of concern tested below Table 910-1 cleanup requirements. Based on these results, WPX respectfully requests closure of this incident.
