Pioneer has tested this well for a limited time and has determined that long-term vacuum operations are mechanically feasible. Pioneer is requesting to impose a partial vacuum at the wellhead per Rule 331. Attached is an exhibit showing the location of all wells on adjacent premises and all offset wells on adjacent lands.
