This COGCC Form 4 is being submitted as a request to meet the background concentration levels for arsenic at the GM 41-4 pad in accordance with footnote 1 to the COGCC table 910-1.

The request is based on the analytical results presented below (see attached laboratory report).

Two composite samples were collected from three separate locations within the cuttings management area to determine the arsenic concentration in the cuttings.

GM 41-4 (cuttings horizontal) - 6.1 mg/kg

GM 41-4 (cuttings vertical) - 4.0 mg/kg

Five grab samples were collected from nearby non-impacted, native soil to establish the background arsenic concentrations.

GM 41-4-B-1 - 2.3 mg/kg

GM 41-4-B-2 - 8.5 mg/kg

GM 41-4-B-3 - 6.7 mg/kg

GM 41-4-B-4 - 7.8 mg/kg

GM 41-4-B-5 - 2.7 mg/kg
