The surface hole is not changing for this location. The latitude/longitude listed on this sundry is the same as the original permit that was issued in 2012. However, the footage from the west line of section 15 in the new well location plat differs from the original plat because an updated field reference point was used for the NW corner of section 15. The reference point changed from PLS 4392 (NW SEC. 15 #4 REBAR W/ YPC) to PLS 22057 (NW COR. SEC. 15 2 1/2 ALUM. CAP).
