WPXENERGY request permission to vent the bradenhaed pressure. Using above surface pressure and csg depth a pressure gradient of 0.326psi/ft was calculated. This is not over the 0.683psi/ft gradient used by the COGCC for compliance, but the 370psi is above the "Mamm Creek" guidelines that this wells location is under. We are requesting permission to vent the bradenhead pressure to a tank for 90 days and then do a 7 day build up test.
