COMMENTS:

WPX Energy requests approval to re-locate previously approved production tanks from the production equipment area to a location on pad. This will allow for further interim reclamation. The water tanks were previously on the east side of the PA 21-2 drilling pad and were moved onto the pad just south of the well heads. There are two water lines servicing these tanks that are denoted on the attached exhibit. The tanks are in a steel lined containment. There are 2-500 BBL Gun-barrels and 14-200 BBL water tanks. Condensate tanks were kept in their original location on the east side of the pad.

Attached is the previously approved BLM sundry, a Form 2A that details other information, an exhibit showing distances to two storage sheds, and an exhibit showing the tanks on the pad.
