1) Locate well, cut cap  
2) Drill out top plug down to the shoe  
3) Run packer, pressure test surface casing  
4) Condition hole  
5) RIH tag stub, pump 200 sack plug from stub to 500' above top of Nio (7095' - 6686')  
6) Pump 320 sack plug from 3900'-4575' to cover the Parkman/sussex  
7) Pump 320 sack plug from 600' to surface  
8) WOC and tag plug  
9) If plug not circulated to surface, place 10 sacks inside casing at surface
