**COMMENTS:**

This COGCC Form 4 is being submitted in order to permit the re-use of treated E&P waste that is currently stored at the PA 43-34 (COGCC Facility #428684). The treated E&P waste was generated during spill remediation activities (Spill tracking #2147955). With the COGCC's approval, approximately 700 yards of treated material would be transported to the Clough Bridge location and used for the road construction.

WPX already received the landowners' approval to proceed with the transportation and re-use of the treated E&P waste. The laboratory results for the treated E&P waste are summarized in the attached table. The analytical laboratory reports and the road location map are included as an attachment.
