COMMENTS:

In consideration of safety, the center stake of the AHU Wyatt 25-43SWD was moved approximately 50' south to gain separation between the new wellbore and existing facilities at the well site. The move was made on a weekend when the conductor pipe was being installed in anticipation of the imminent arrival of the drilling rig. The layout of the drilling rig (Capstar Rig #311) was known at the time and it was apparent that no additional surface disturbance would be required. The move was done with all good intention and created no additional surface disturbance, however no such action will be done in the future without the pre-approval of the appropriate regulatory body.
