PDC sent pre-application notifications to all BU owners in February, none of which requested a meeting. We recently contacted the surface owner who approved of the re-configuration. We also contacted the owner of BU1 who approved of the re-configuration.

PDC will comply with the safety setbacks listed in the MLVT policy.
