Attached with this COGCC Form 4 is the sampling summary for the groundwater samples collected in the fourth quarter of 2014. The COGCC remediation number for this project is 5258.
The 2014 fourth quarter sampling event was completed on October 8, 2014. Results are summarized in the attached Table 1. MW 2, MW3, MW8, and MW 9 continue to exceed the COGCC cleanup concentrations for benzene. Therefore, WPX installed Barometrically Assisted Remediation Technology (BART) valves which are utilized for passive in-situ vapor extraction of VOC's from the vadose zone soil above the hydrocarbon impacted groundwater. A total of 17 ports were installed.
