Set a Retrievable Bridge Plug at 659' and then ran a packer to isolate the production casing leak. Found Casing Leak between 2824'-2856'. A cast iron Bridge Plug was set at 3206' with 2 sacks of cement on top PDC engineering currently evaluating plans to repair or plug the well.
