Such well is located 470' from the Mojack I-28HN (API 05-123-39826) and 500' from the subject Mojack L-28HN well. The Mojack 2-28 well log is representative of the stratigraphy for all wells on the Mojack 28-C Pad. Cement bond logs will be run as part of the completion process for all wells drilled on the pad.
