Spill/Release tracking number is 2148514.  
 Attached are the laboratory reports and the sample location map for the soil samples collected from the excavated area and landfarm in order to close the historical produced water and condensate release that occurred at the RMV 229.27 well pad and was discovered on April 1, 2014.

- Five grab samples were collected from the impacted area and were analyzed for the constituents listed in Table 910-1.
- Three grab samples were collected from nearby non-impacted, native soil to establish the background concentrations for arsenic. In accordance with the COGCC Rule 910.b.(3)E. one grab sample was analyzed for inorganics to establish background soil conditions. As the attached lab reports indicate, all constituents of concern listed in the COGCC Table 910-1 tested below the cleanup requirements or below the background concentrations with the exception of the inorganics. Therefore, in accordance with COGCC guideline Q32 regarding inorganics, the excavation was backfilled with clean soil.

Based on these results, WPX respectfully requests closure of this incident.
