**COMMENTS:**

Marathon Oil Company requests continued TA status for this well pending future completion to a gas producer. There are three producing gas wells on this well pad, and this well has future potential as a gas well when market conditions improve.

The well has a 4-1/16", 10,000# frac valve on the well. A 4-1/16" night cap flange is bolted to the top of the frac valve to provide additional security.
