Workover

Comment: COGCC Field Inspector spoke with BP company man (Josh McGaha) during workover inspection. Key #6115 in process of drilling out cement plug to increase rat hole depth. Rig was working through a "tight spot" (2900' in perf's) at time of inspection; Plug back depth starts at 3060' ; Drilling out plug to TD @ 3110'. Observed liquid (fresh water) on ground (< 1bbl) under tubing float; Inspector discussed COGCC 906 spill rules and advised that all fluids be contained through rest of project. A flow back tank on site contained well fluids/ debris. Inspector observed spill prevention BMP's under equipment and sampling points.
