Comment: The COGCC SW Field Inspector Joe Maclaren met with Wade Duncan (Samson Resources Company Man) and Paco Rivera (Black Hawk Rig #3 Pusher) while on location and informed of the following: A hole in the tubing was found at 3465'; Repairs were being completed/ finalized at time of inspection; A total of 20 joints of tubing were replaced in this well; No evidence of a casing integrity issue identified. The field inspector observed use of spill prevention BMP's under equipment and a laydown tank on site to contain fluids.
