The following corrective actions were completed as observed during the follow up field inspection conducted on 11/11/14: The signage at the produced water tank has been updated (including capacity) to meet rule 210d; Stained gravel/ soils around the pumping units have been removed/ remediated; New gravel has been added around equipment on location to prevent stormwater accumulations; Weeds on wellpad, near equipment and on fence lines have been removed; Ownership of tubulars on pipe racks on NE corner of fenced yard have been confirmed to be the property of the landowner (Submitted to COGCC in writing). The operator completed the actions required by the date outlined and effectively communicated the work completion via email of paperwork/ pictures to the COGCC SW Field Inspector.
