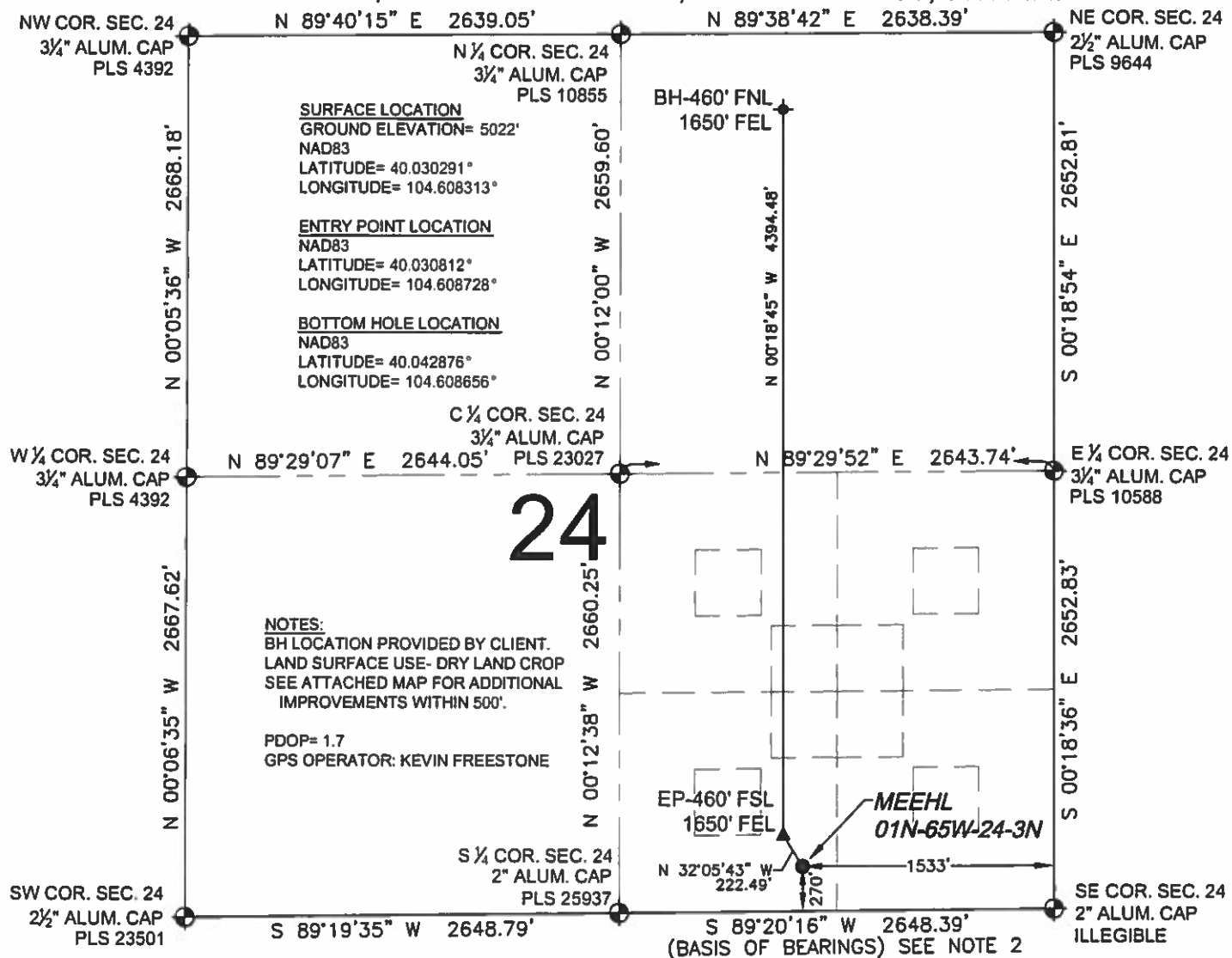


WELL LOCATION CERTIFICATE: MEEHL 01N-65W-24-3N

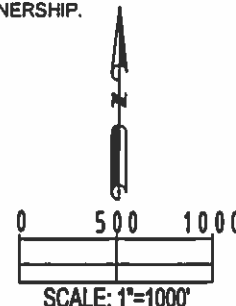
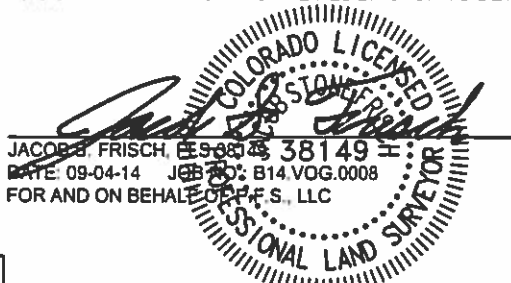
- ⊕ = EXISTING MONUMENT
