Was asked by Ryan Costa to investigate the Noise Level at this well site. On site at 10:20 am. The surrounding area description is mountainous area with evergreen, pine and fur trees. The source of the noise was a well site compressor with 2 mufflers, with the exhaust placement direction being straight up. The following data was collected West of the noise source 351 ft (117 yds). I collected the A- Scale data. Time : 10:35am, 10:38, 10:40, 10:43, 10:45, 10:48, 10:50 ; Wind Speed (East) : 2.5 mph, 3.3, 3.5, 5.7, 2.6, 0.8, 0.0 ; Noise : 52.5dbs, 52.3, 51.9, 51.5, 50.4, 51.2, 53.0 . Ryan Costa collected the C - Scale data. Time : 10:55am, 10:58, 11:00, 11:03, 11:05, 11:08, 11:10 ; Wind Speed (East) : 2.3 mph, 1.6, 2.8, 3.8, 3.5, 0.0, 1.0 ; Noise : 63.5 dbs, 63.4, 63.6, 62.9, 63.2, 63.6, 63.8 .
