Nick,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

1) This 2A was submitted with information that pertain to production facilities, however, it will only have oil and gas wells. Therefore, I would like to remove the following BMPs as they are not relevant:

- A - Leak Detection Plan
- B - Berm Construction
- C - Green Completions / Emission Control Systems

2) In the Water Resources section, you have identified the nearest downgradient surface water feature as being a ditch located 191 feet to the east. However, topographic downgradient in the area of this proposed oil and gas location appears to be to the west and the nearest surface water feature in that direction is the Eaton Ditch, approximately 3,750 feet to the west. Therefore I would like to change this distance.

3) In the Related Remote Locations section you used the Form 2A Document # to identify the production facility these wells will produce to. As that Form 2A has been approved by the COGCC and a Location ID (#439635) has been established for that production facility, I have changed that.
