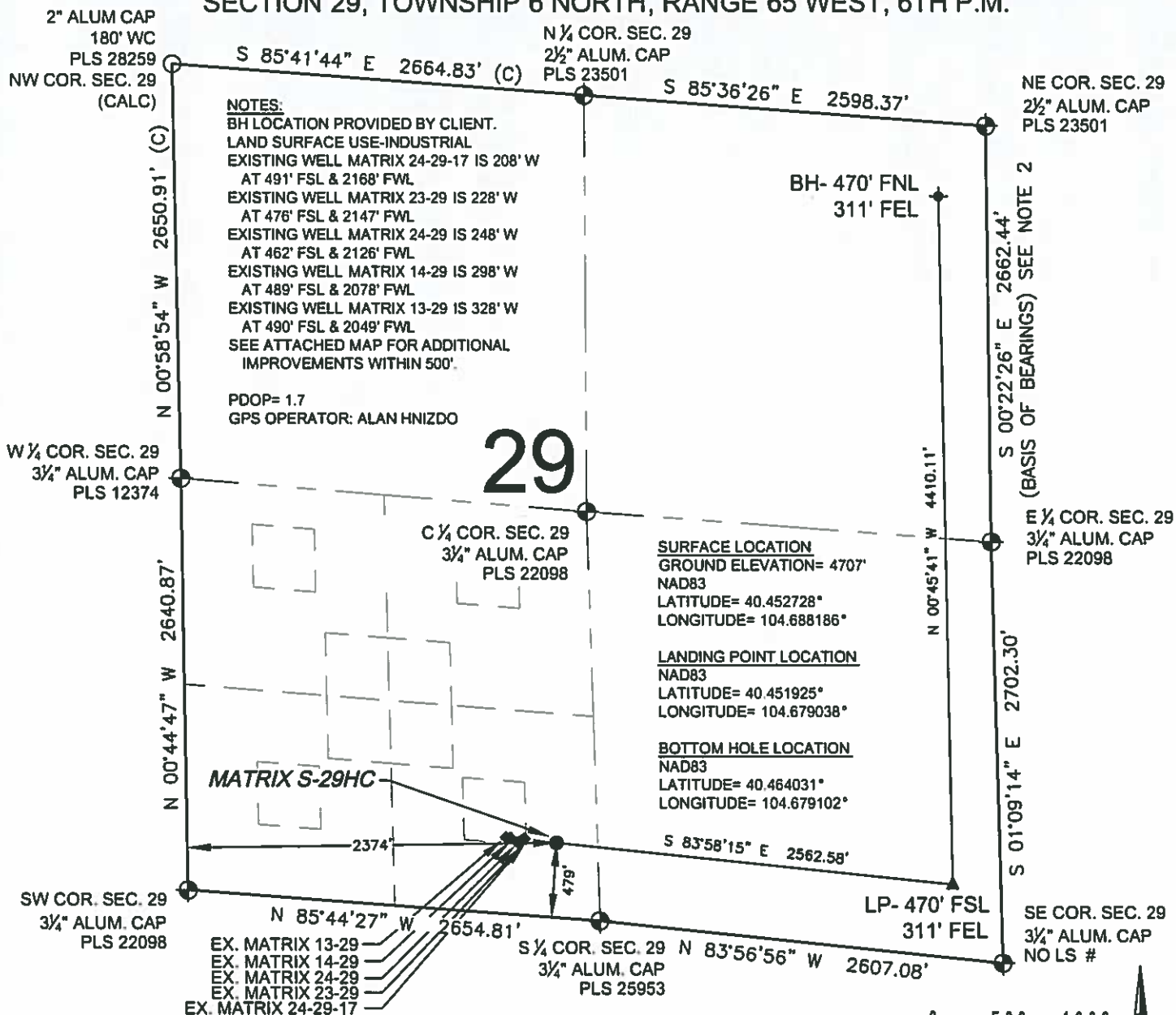


WELL LOCATION CERTIFICATE: MATRIX S-29HC

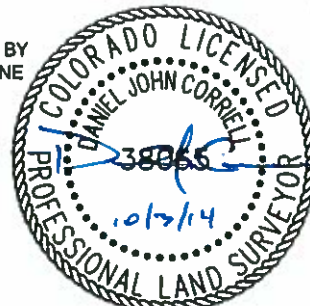
