This form is being filed as a refile on a location that had no previous 2A. The eleven wells assigned to the location were Sundried as AL's and are being moved approximately 150' West, with the location, as refiles. The pad has not been built. The wells were not drilled

The distance to lease line was measured from the BHL to the west of the Puckett 5,141 acre lease in Section 12.
