#### COMMENTS:

WPX Energy requests approval to revise the frac plan that was previously approved for the GM 11-28 pad. Initially, the plan was to build and use the existing MV 53-28 pad as a frac pad. However, the GM 323-28 pad (and frac pad) is currently built which can be used for the frac pad instead. 3-4.5" temporary, surface, steel frac lines would run up an existing pipeline corridor to the GM 11-28 pad. This corridor was already analyzed and approved for use of laying a surface water line to the GM 11-28 pad. The attached exhibit shows the change compared with the initial plan.

The wells on this pad, or permitted on this pad, are as follows – all wells in Fed lease COC 24099:
