PLANNED SIDETRACK:

There is limited well data in the area, taking a core of the vertical well will assist in calibrating our models to better understand and predict well performance. An Open Hole Log will be run along with the coring of the vertical well..

OTHER DISPOSAL DESCRIPTION:

Drilling fluids disposal: KMG will reuse water-based drilling fluids to the maximum extent at which point they will either be land applied or taken to a licensed, commercial disposal site; decided upon based off of laboratory analysis of fluids. Cuttings disposal: Water-based cuttings will be disposed of using a Centralized E&P Waste Management facility or a private spread field depending on what is feasible at time of drilling.
