Encana Services Company is making application for a drilling permit for the above captioned well.

As currently planned, the wellbore(s) listed below in Section A will lie within 150 feet of the horizontal lateral of the captioned well.



Prior to drilling operations, Encana will perform an anti-collision review of existing offset wells that have the potential of being within close proximity of the proposed well. This anti-collision review may include MWD or gyro surveys and surface locations of the offset wells with included error of uncertainty per survey instrument, and compared against the proposed wellpath with its respective error of uncertainty. If current surveys do not exist for the offset wells, Encana may have gyro surveys conducted to verify bottom hole location. The proposed well will only be drilled if the anti-collision scan results indicate that there is not a risk for collision or harm to people or the environment. For the proposed well, upon conclusion of drilling operations, an as-constructed gyro survey will be submitted to COGCC with the Form 5.

Rule 318A.n of the Colorado Oil and Gas Commission's Rules and Regulations states that "no horizontal wellbore lateral shall be located less than 150 feet from any existing or permitted oil or gas wellbore." For wells listed in Section A: encroached-upon offset operators, other than Encana, must give written consent. Consent from Extraction Oil and Gas is attached. For wells listed in Section B: encroached-upon offset operators, other than Encana, need to be notified of the upcoming development. KPK has been sent such a notice.

Encana respectfully requests the Director allow the captioned well to be drilled within 150 feet of the well(s) listed in Section A and/or Section B above.

Encana Oil & Gas (USA) Inc. ("Encana") is seeking to drill the captioned wells located in Weld County, Colorado. It is contemplated that the wellbore path for the Wells will pass within 150' of the Grant Brothers 34-23C well, which is operated by Extraction Oil & Gas.

The Colorado Oil and Gas Conservation Commission Rules, Greater Wattenberg Area Well Location, Rule 318A.n., provides (emphasis added):

Minimum intrawell distance. No horizontal wellbore lateral shall be located less than one hundred fifty (150) feet from any existing or permitted oil or gas wellbore as illustrated in the directional survey for drilled wellbores or as illustrated in the deviated drilling plan for permitted wellbores or as otherwise reflected in the COGCC well records. *This requirement may be waived in writing by the operator of the encroached upon well.*

Encana respectfully requests that Extraction Oil & Gas waive this requirement and grant its consent to allow Encana to drill the Wells with the 150' minimum intrawell distance provided for in said rule by signing and returning the attached signature page to the undersigned.
