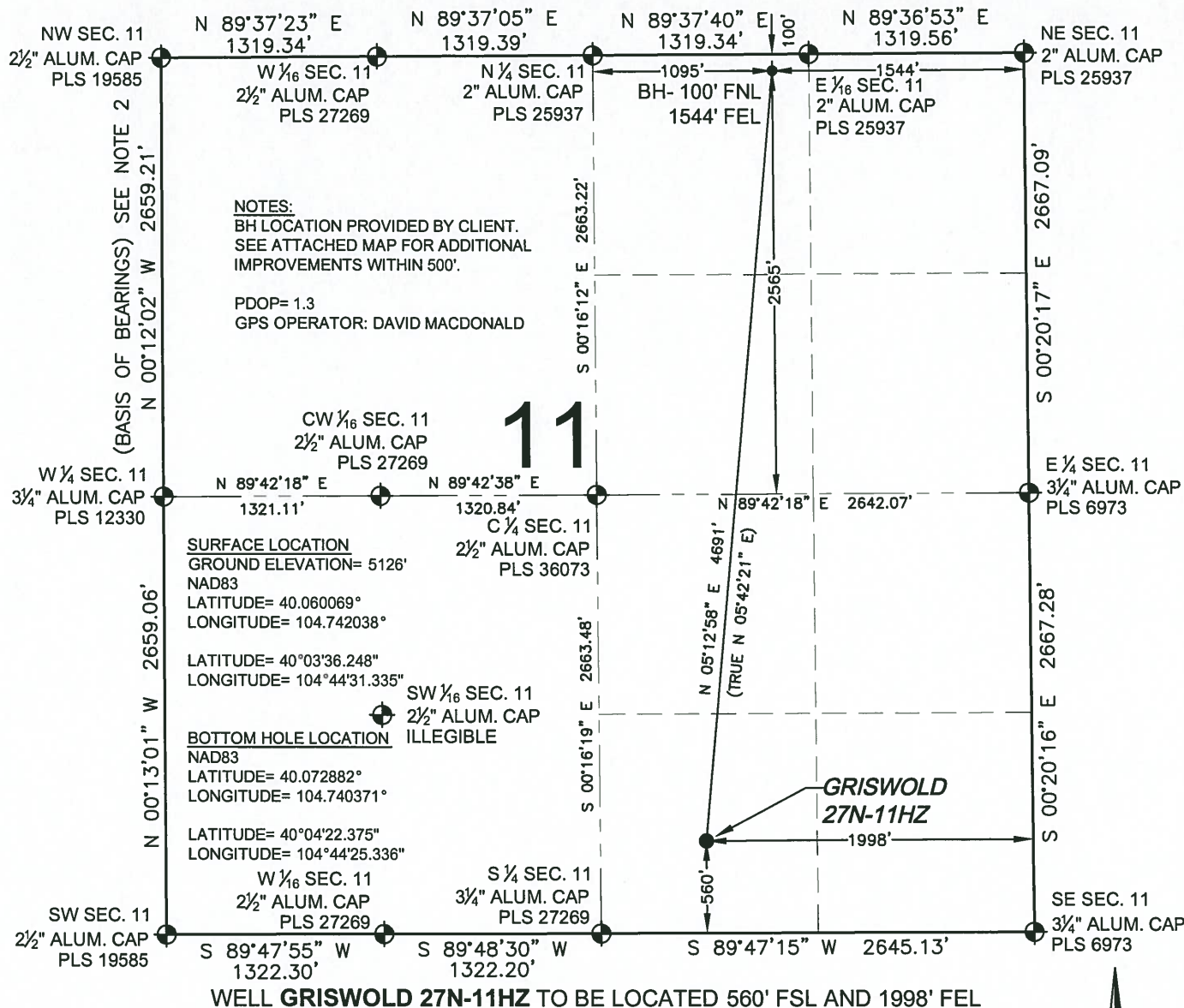


WELL LOCATION CERTIFICATE: GRISWOLD 27N-11HZ

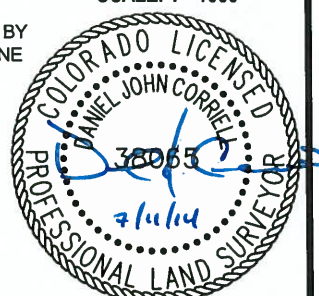
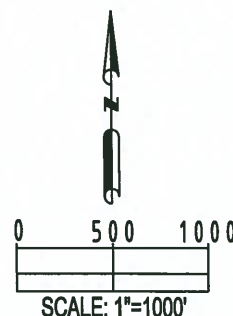
