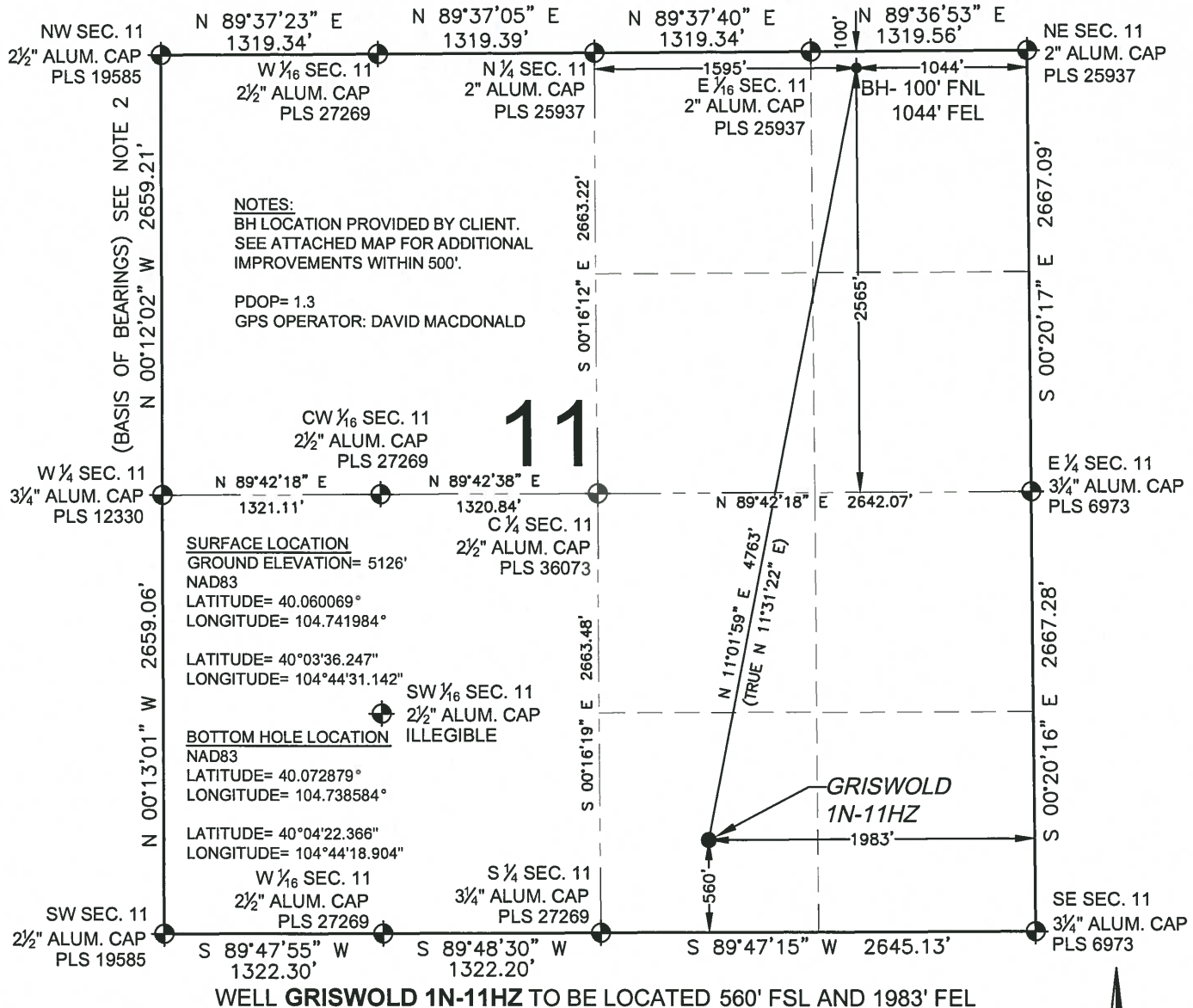


WELL LOCATION CERTIFICATE: GRISWOLD 1N-11HZ

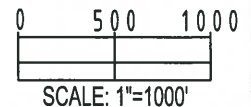
- ⊕ = EXISTING MONUMENT ⊕ = BOTTOM HOLE
