Comments An unsuccessful attempt to re-enter the lateral resulted in fish stuck in hole at +/- 10,295' MD. Total TD reached: 13,113' MD & 5,639' TVD 89.32 degrees Inc, 181.31 degrees Azi. Casing Strings set: 16" conductor set at 80', cement circulated to surface. 9-5/8" surface string set 1,589.5' MD, cemented with 710 sx Type III cement. 7" intermediate string set at 6,153.7' MD, cemented lead 1: 460 sx 1-2-6 Class G cement Tail: 210 sx 1-1-0 Class G cement. Description of fish in hole: Bit 1', Bit Sub 3.5", 1 Jt HWDP 31.42', fish left at +/- 10,295' MD. Plugback depths: none, open hole sidetrack.
Sidetrack KOP: 8,205' MD & 5,655' TVD. BHL target same as originally permitted.
Verbal approval to sidetrack was granted by Diana Burn on October 5, 2014 via e-mail, copy attached. The BHL will remain the same at 600' FSL & 2,475' FEL Sec 34-T10N-R58W. The difference in the MD at TD is due to the fact that we will be drilling negative vertical section in the wellbore to maximize the lateral length.
