Gas analysis taken 11/15/2014 identified High H₂S concentration in the gas stream. Samples were pulled from the 4 production tanks on location with H₂S Drager Tubes and concentrations were 1 ppm and 0 ppm H₂S. Water samples were collected from the tanks and a detailed analysis will be performed and forwarded on to the COGCC.
H₂S placarding is being installed on the tanks and separators.
Piceance Energy is currently treating the well with an H₂S scavenger chemical. The gas stream will be re sampled once the treatment has had a chance to work.
