Containing 480 acres more or less.

Mineral Resources is not the only owner within the proposed wellbore spacing unit and has provided notice to the remaining owner(s) within this spacing unit, as required by COGCC Rule 318A.e.(6). Copies of the required notification letters are on file at Mineral Resource's office. The required thirty (30) day notice period has elapsed absent the receipt by Mineral Resources of any objection to their proposal by the owner(s) within the proposed spacing unit for the subject well.

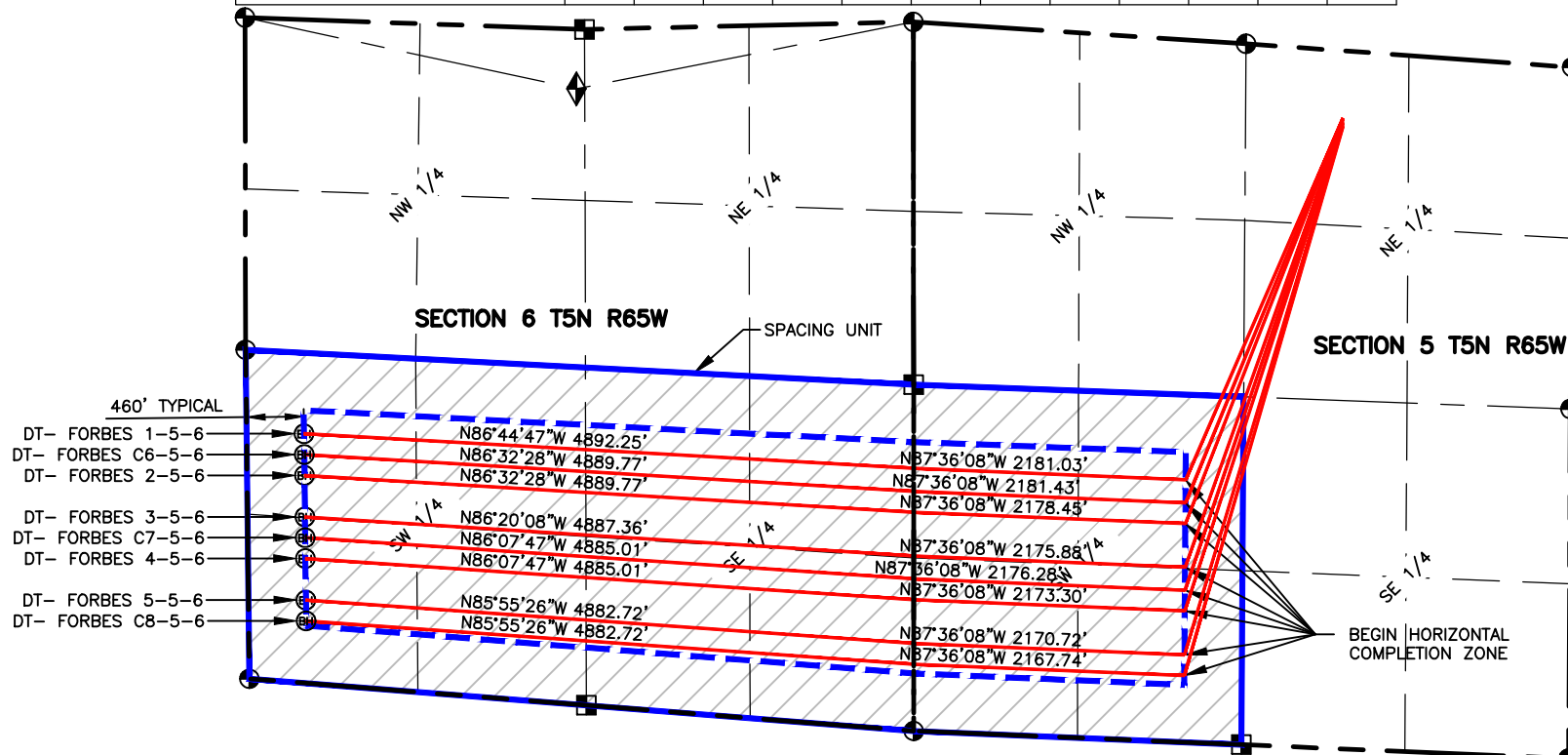
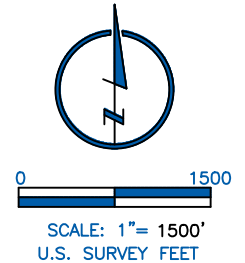
