Terry,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

- 1) Per COGCC Rule 303.b.(3)C, a description of all oil, gas, and/or water pipelines is required on the Form 2A. What we are looking for is a simple description (number, size, material) of each line that flows from the well to the separator to the tanks on this proposed oil and gas location.
- 2) A review of your Location Drawing indicates the distance to the nearest Public Road (CR 88) is greater than a mile. Therefore I will change this distance in the Cultural Distance section of the Form 2A.
- 3) A review of your Location Drawing indicates the distance from the the Production Facility to the nearest Above Ground Utility and Property Line is 1,999 feet and 448 feet, respectively. Therefore I will change those distances in the Cultural Distance section of the Form 2A.
- 4) In the Water Resources section you have indicated the nearest water well (7,656 feet) and the estimated depth to groundwater (144) is from water well Permit #37178. However, the attached water well permit is for Permit #293044. This water well is located approximately 4,400 feet southwest of the proposed oil and gas location and its listed depth to groundwater 63 feet. Therefore, I will change that info in the Water Resources section.
- 5) You have indicated that the right to construct this proposed oil and gas location is granted by a Surface Use Agreement. Please provide us with an executed copy of the Surface Use Agreement and I will attach it to the Form 2A.

- 2) A review of your Location Drawing indicates the distance to the nearest Public Road (CR 88) is greater than a mile. Therefore I will change this distance in the Cultural Distance section of the Form 2A.**[Terry Hoffman] The County Road (88) to the north is 1.6 miles and the Oil & Gas service road to the East is 1964' (used by the Public). I couldn't get anyone at the COGCC to confirm what footage they wanted on the Form 2a so I went with the 1964' because it is a road traveled by both the public and Oil & Gas company's.**
