Comment: Vegetation is progressing throughout the interim reclamation area. Approximately 50 musk thistle (Carduus nutans) occur within the interim reclamation area. Musk thistle is a Colorado State and Montezuma County-Listed noxious weed. Weeds need to be controlled during the appropriate season but no later than seedhead maturity in 2015. Large slash piles along the access road and edge of project area will need to be removed or redistributed during final reclamation.

Erosion is occurring within the stormwater diversion channels along the northeastern edges of the working area. It appears that sediment is largely contained on the site due to vegetation within the interim reclamation area. Erosion along the stormwater diversion channels needs to be monitored and stormwater BMPs applied to de-energize and filter stormwater flows if erosion worsens. See attached photos.
