This well was originally permitted from the Watson Ranch A Pad (Loc ID 413055) and is now being changed to be drilled from the Watson Ranch B pad location (2A Doc #400725879). The updated SHL, BHL and well name revisions (along with all required attachments) are provided with this refile APD. First String / Production cement will be > 500 feet above TOG. Distance to nearest well completed in the same formation / permitted or existing well penetrating objective formation was measured to the existing BAT 22D-17-07-95 (API 05-045-18713).
