Bill Barrett Corporation has requested an extension to Rule 1003 Interim Reclamation requirements through August of 2015. BBC spud 10 wells on the pad and drilled and completed 5 of them (5 of them remain undrilled). BBC is currently evaluating production results to determine potential to re-occupy and drill the remaining 5 wells. All stockpiled soils shall be protected from degradation and best management practices to prevent weed establishment and to maintain soil microbial activity shall be implemented.
