Mr Andrews,

Originally state depth of 177' is the last survey, actual hole depth is 237' MD. Below are the requested details.

v. Cement plug details – set from 237' to 75', 162' height, 35.3 bbls, 168 sacks.

vi. Cement properties – cement plug slurry, 15.6 ppg, 1.18 cf/sk.

vii. Measured depth of proposed sidetrack kick-off point – the original wellbore deviated from plan at 105', the plan is to correct it. The kick off point therefore becomes 105' MD.

Let me know if you need any additional information. Please advise if we have to submit a sundry for a sidetrack. Thank you.

Hello Mr. Andrews, I've left a voicemail on your cellphone detailing a plan for plugback on RGU 33-26-198.

Hole depth is 177', conductor set at 86'. We are planning on pumping a cement plug from 177' to conductor and re-drilling the wellbore. The wellbore pointed off track and could cause a potential anticollision issue. No changes to surface or bottom hole locations. The sidetrack will be drilled exactly to the original plan. I will send you all the sidetrack details tomorrow morning once I have more information. Currently the rig is off bottom, no operations were carried out. Please give me a call if you have any questions. Thanks.
