The subject well is the only well producing in the section. The initial permit allocated 320 acres to the D-Sand and J-Sand. A Sundry was filed to change the spacing to 40 acres in the NW/4SE/4 of both the D-Sand and J-Sand. The subject well lies within the terms of a USX Exploration agreement dated 11-15-2005, "if no unit or spacing rule exists, then drillsite spacing unit shall be defined as the eighty (80) acre tract surrounding an oil well or three hundred twenty (320) acre tract surrounding a gas well" (item 7 of the attached Oil and Gas Lease). This well is now producing from the D-Sand (J-Sand has been released). Noble requests the spacing unit configuration for the D-Sand be changed to 320 acres covering the S/2 of 3S-64W-3.
