If part of the pit does not freeze due to pumping or discharge of produced water into the pit, then that section of the pit must be netted and isolated so that no access to the water is possible for birds and other wildlife. ***** 2) It is the responsibility of the operator to protect wildlife from having access to (unfrozen) water of the pit. Nets shall be reinstalled if condensate or oil is observed on the pit. Nets shall be installed if pits are accessible to wildlife. ***** 3) Netting needs to be reinstalled over fluid pits upon thawing of the pits' contents. Nets will be reinstalled before Sage Grouse nesting season begins on March 1st.
