COMMENTS:

Attached is the laboratory report and the sample location map for the samples collected from the impacted area and drainage in order to close the flowback water release that occurred at the RMV 29-27 well pad and was discovered on June 12, 2007 (COGCC document # 1630702). Based on the samples collected at the time the release was discovered, closure is warranted. Two water samples were collected on 6/20/07 from the impacted drainage and were analyzed for BTEX and Chloride. As the attached lab report indicates, hydrocarbon concentrations were non-detectable. On 6/18/07, two grab soil samples were collected from the impacted area and field screened for TPH concentrations. The soil samples tested at 978 ppm at Point 1 and 872 ppm at Point 2, which were below the COGCC cleanup requirements applicable at the time of the incident. (see attached map for the sample locations) Based on these results, WPX respectfully requests closure of this incident.
